EXECUTIVE SUMMARY:

Funding for Local Authority projects is part of a grant received from The Department of Chief Minister and Cabinet and invested in projects to benefit and improve the community.

Examples of acceptable purposes for expenditure include:

- Repairs and maintenance of community assets controlled or owned by Council
- Acquisition of plant and equipment directly related to local government service delivery.
- Upgrade/enhancement of community sporting facilities.
- Festivals or other events, but must only be conducted within a council's own Local Authority area.

Funds from the 2019/2020 and 2020/2021 Project fund have been fully allocated to Infrastructure projects within the Community.
