8.1 LAND TENURE UNIT - DEPT INFRASTRUCTURE, PLANNING AND LOGISTICS NT

EXECUTIVE SUMMARY:

In consultation with NTG departments and with the support of the Commonwealth Government the Land Tenure Unit of the Department of Infrastructure, Planning and Logistics have developed a Remote Community Planning Framework (the Framework) that applies to the development of 50 remote Aboriginal communities. The purpose of the Framework is to provide a responsive planning regime that provides for the orderly development and use of "unzoned land". It does not replace any of the current provisions of the Planning Scheme that apply to "unzoned land", nor does it have any legislative backing.

The primary component of the Framework is the Community Land Use Plan (CLUP). These plans are developed in consultation with the land owners, the communities and various government agencies and once adopted will form the basis of future development, both in built form and infrastructure, in the relevant community.
